We hope to see you at one of the 3 regional CONNECT conferences



LEGISLATIVE HIGHLIGHTS

Greetings. This was an active legislative session for CTEI. Please pay attention to the following three bills that impact Career and Technical Education in Idaho. The following are some of the highest impact bills for our CTE community.

H0267: The intent of this legislation is to expand the capacity of career technical education (CTE) in Idaho middle and high schools (grades 7-12). The legislation has two components. The first component is the Idaho Career Ready Students (ICRS) Program, which will be created as a capital fund for Idaho public secondary schools. This fund will be established in the State Department of Education and administered by the Idaho Career Ready Students Program Council (CTEI will be important in selecting three individuals to serve on this board). The second component updates added-cost funding, which will now have a foundation in Idaho law.

H0196: This bill requires signed parental permission for students to be able to participate in school clubs. It further requires that the board approve and oversee the publishing of an annual list of all school clubs, advisors and a description of the club and activities.

H0292 - Vetoed by Governor Little, then both chambers voted to override the veto: This legislation provides property tax relief to property taxpayers in Idaho. Approximate \$100 million will be distributed to school districts on an average daily attendance basis. School districts are required to use funds in the order of priority as follows: (1) payment of school bonds (2) payment of school levies (3) saved for future school facility construction needs (4) used for new bonds. This legislation also eliminates the March date that school districts can use for elections.
